

BRUNET-JAILLY, Emmanuel

Emmanuel Brunet-Jailly, (Ph.D. UWO, 1999) Professor and Jean Monnet Chair, School of Public Administration, University of Victoria, B.C. Canada, is lead of 21st Century Borders (\$5.6 million research project). He has published work in comparative urban governance, governance and theorization of cross-border regions in 17 books and special issues of academic journals, and over 100 book chapters and articles.

CANTENS, Thomas

Thomas Cantens currently works as head of research and policy unit at the World Customs Organization. Prior to taking his position at the WCO, he served in investigation and intelligence in French Customs and in three sub-Saharan Customs administrations, Mali, Cameroon and Niger. Thomas is an Associate Researcher at the Research Centre on International Development of the Auvergne University (CERDI, France). Having initially graduated as an engineer (POLYTECH Montpellier, France), he holds a PhD in social anthropology and ethnology (Ecole des Hautes Etudes en Sciences Sociales, France) and a postgraduate certificate in geospatial analysis (Ecole Nationale des Sciences Géographiques, France). He has published articles, research papers and books on customs reforms, quantification, and fragility and taxation.

DEAN, Karin

Karin Dean is a senior researcher at the School of Humanities, Tallinn University, currently leading a EC Horizon project Eur-Asian Border Lab, advancing trans-regional border studies. Her research interest revolves around borders—on how different actors construct, negotiate and cross physical, symbolic or virtual borders in their claiming of political space. Her recent research explores large infrastructure developments at China's borderlands with Southeast Asia (Myanmar), seeking to unpack the new emerging assemblages and practices of bordering. Karin obtained her PhD in political geography at the National University of Singapore.

DESSBERG, Frederic

Frédéric Dessberg is Associate Professor at Paris 1 Panthéon-Sorbonne University, detached at Saint-Cyr Military Academy. He is heading the Research Department « European Defence and Security » at Saint-Cyr Research Center, is member of UMR SIRICE (Sorbonne) and holds a Jean Monnet European Chair. He is interested in the French policy in Central and Eastern Europe between the two World Wars. His Phd dissertation about the relations between France, the Soviet Union and Poland from 1924 to 1935 has been published with the title Le Triangle impossible (Bruxelles, PIE-Peter Lang, 2009). FERRIL, Jamie

Dr Jamie Ferrill is the Discipline Lead of Financial Crime Studies and Lecturer in the same at the Australian Graduate School of Policing and Security, Charles Sturt University. She is currently a visiting fellow at the Academy for International Affairs NRW in Bonn. Jamie has nearly a decade of law enforcement experience, having worked for Canada Border Services Agency prior to commencing an academic career. She holds a PhD in Organizational Behaviour from Loughborough University (UK), a Masters in Homeland Security Leadership from the University of Connecticut), and a Bachelors in Criminal Justice from Mount Royal University (Canada). A political sociologist, Jamie researches threats to national and economic security. Her work focuses on the role of human actors and ideology in organisational processes, as well as in transnational cooperation and collaboration.

LEUPRECHT, Christian

He also directs the Institute of Intergovernmental Relations in the School of Policy Studies and is an Adjunct Research Professor in the Australian Graduate School of Policing and Security at Charles Sturt University. A former Bicentennial Professor in Canadian Studies at Yale University, Eisenhower Fellow at the NATO Defence College, and Fulbright Research Chair in Canada–US Relations at John Hopkins University's School for Advanced International Studies, he is an elected member of the College of New Scholars of the Royal Society of Canada and recipient of the Cowan Prize for Excellence in Research at the Royal Military College of Canada.

SOHN, Christophe

Christophe Sohn is an urban geographer and border scholar working as a senior researcher at the Luxembourg Institute of Socio-Economic Research (LISER). His research agenda focuses on cross-border integration dynamics, urban and regional governance and the concept of borders as a resource. He has notably published several articles and books examining how national borders may represent economic, political or symbolic opportunities for border cities and regions. Christophe is particularly interested in the concept of cross-border metropolitan regions as the emblematic configuration of globalizing urban border regions and has conducted empirical research in border cities and regions such as Basel, Geneva, Copenhagen-Malmö, Luxembourg, Vienna-Bratislava and San Diego-Tijuana. His most recent work focuses on the symbolic recoding of borders in cross-border regionalization initiatives in Europe and in North America. Since 2018, Christophe is the co-editor-in-chief of the Journal of Borderlands Studies.

VIRKKUNEN, Joni

Dr Joni Virkkunen works as Research Manager at VERA Centre for Russian and Border Studies, Karelian Institute, University of Eastern Finland (UEF). Since receiving his PhD in 2002, his tasks have related to research and research coordination within Russian and border studies and doctoral training at the UEF. His research relates to borders, border governance, cross-border cooperation and EU-Russian relations and transnational migration in Russian and post-Soviet contexts. In his recent research, he has been looking at the 2015-2016 Arctic route through/from Russia to the EU, weaponization of migration and the related insecurities, migratory strategies and failed integration of Afghan and African immigrants in Russia.
